VII. OFFER EVALUATION CRITERION AND WAY OF EVALUATION

The Orderer will choose the offer comparing the criterions:

• price (net in the case of Polish suppliers/gross in the case of foreign suppliers), evaluation consists in calculation of quotient of the lowest price to the offered price,





where the lowest price offer will get 1 point, then evaluation is multiplied by 85 % weight.

• time of payment, evaluation consists in calculation of quotient of the offered time (in the case when the Tenderer foresees partial payments, the Orderer will consider the time of payment of the last instalment, so settling the whole order) of payment to the longest time, where the offer with the longest time will get 1 point, and then evaluation is multiplied by 15 % weight.

The Orderer will choose a contractor on the basis of the placed offers.

By sending an e-message the Orderer will inform the tenderers which placed the offers about choice of the most profitable offer within 7 calendar days from the date of making a choice confirmed by a protocol of choice.

- possessing at least 5 % of shares or stocks,
- acting as a supervisory or managing organ member, proxy or plenipotentiary,
- being in a such legal or real relationship, which can cause justified doubts as for impartiality in choice of a contractor, especially being in matrimony, lineal blood relationship or kinship, second-degree blood relationship or kinship in sideline or in adoption, under care or wardship.
