II. MODE OF ORDER AWARDING The order will be awarded according to the rule of competitiveness and does not undergo the regulations of Public Procurement Law. The order being the subject of the present inquiry is co-financed by The European Union within **The European Regional Development Fund and the means from European Funds for Smart Growth.**

III. ORDER SUBJECT AND DESCRIPTION OF ORDER SUBJECT The subject of the present inquiry is:

-air transport for individuals (**3 persons**) on the route Poland – United Kingdom – Poland. The orderer accepts following route solutions:

VII. OFFER EVALUATION CRITERION AND WAY OF EVALUATIONThe Orderer will choose the offer comparing the criterions:

- price (net in the case of Polish suppliers/gross in the case of foreign suppliers), evaluation consists in calculation of quotient of the lowest price to the offered price, where the lowest price offer will get 1 point, then evaluation is multiplied by 85 % weight.
- time of payment, evaluation consists in calculation of quotient of the offered time (in the case when the tenderer foresees partial payments, the Orderer will consider the time of payment of the last instalment, so settling the whole order) of payment to the longest time, where the offer with the longest time will get 1 point, and then evaluation is multiplied by 15 % weight.

The Orderer will choose a contractor on the basis of the placed offers.





By sending an e-message the Orderer will inform the tenderers which placed the offers about choice of the most profitable offer within 7 calendar days from the date of making a choice confirmed by a protocol of choice.


IX. SCOPE OF EXCLUSION
